Part IX, Line 25 - The total Management and General Expenses were \$215,898 or 8.7% of total functional expenses.

Excluding the Deja vu Thrift Store expenses (\$141,072), Management and General expenses were \$74,826 or 3.0% of total functional expenses.

Accordingly, excluding the Deja vu Thrift Store, 97% of all expenditures were distributed to poor and needy individuals and families.

If we look at the amount that members contributed (\$190,367), this entirely covered all Management and General expenses (excluding Deja vu Thrift Store) and therefore, 100% of donations received from the public were distributed to poor and needy individuals and families.
